TO RETURN TO ACTIVE STATUS** OCT 19 2009

6 On October 5, 2009, the application by Ryan Mitchell, D.O., License #1113, to return to
7 active licensure from inactive licensure for the remainder of the calendar year 2009 came on
8 before the Nevada State Board of Osteopathic Medicine ("Board") for hearing. Upon request
9 of the physician, the matter was heard in closed session pursuant to NRS chapter 241.

10 Thereafter and for purposes of decision, the matter reopened for a public hearing. A
11 motion was made to deny the return to active status, which was seconded by another Board
12 member. Discussion was then had concerning various issues and after further discussion, a
13 vote was taken; four (4) Board members voted to approve the motion to deny, and one (1)
14 Board member voted against the motion. Two members recused themselves (Drs. Manthei
15 and Curtis). Based upon the vote, the motion carried, and the return to an active license for
16 2009 was denied.

17 Counsel for the physician asked for guidelines of what should be accomplished prior to
18 the physician reappearing before the Board for licensure for the calendar year 2010. Dr.
19 Kalekas stated that insufficient time has elapsed. Discussion was then had concerning
20 placing restrictions and/or limitations on his osteopathic medicine license. Dr. Kalekas
21 admonished that there should be no other issues with this physician prior to him reappearing
22 before the Board for licensure in the year 2010, and that further documentation could be
23 provided to the Board in support of him returning to active status.
