The Nevada State Board of Osteopathic Medicine (the Board) met on November 13, 2012 and held a hearing regarding the Hearing Officer's Findings of Fact, Conclusions of Law, and Recommendations in this matter. At the hearing, the Board was advised by Sophia Long, Deputy Attorney General, the Board's staff was represented by Louis Ling, Board Counsel, and Dr. Michael Jenkins appeared and represented himself. Mr. Ling and Dr. Jenkins each presented argument regarding the Findings of Fact, Conclusions of Law, and Recommendations and what discipline, if any, would be appropriate. The Board members asked such questions of the parties as they deemed necessary. Thereafter, the Board discussed, deliberated, and ruled.

IT IS ORDERED that the Findings of Fact, Conclusions Law, and Recommendations entered by Hearing Officer Jill Greiner, Esq. on October 1, 2012 which were filed by the Board on October 4, 2012 is hereby adopted and ratified in its entirety and made the findings of fact and conclusions of law of the Board in this matter. A copy of the Findings of Fact, Conclusions of Law, and Recommendations is attached hereto as Attachment 1 and is incorporated herein in its entirety by the reference.

Based upon its adoption and ratification of the Findings of Fact, Conclusions of Law, and Recommendations, the Board hereby orders the following as the discipline in this matter:

- 1. Dr. Michael Jenkins' license to practice osteopathic medicine in Nevada (License No. 1451) is revoked effective November 13, 2012.
- 2. Dr. Jenkins shall pay the Board's fees and costs of investigation and prosecution in this matter totaling \$26,793.53 which shall be paid by certified check or money order made payable to: "Nevada State Board of Osteopathic Medicine." The certified check or money order must be received by the Board's office no later than 60 days from the effective date of this Order.

- 3. Dr. Jenkins shall pay a fine of \$5,000.00 for the three causes of action that he was found to have violated which shall be paid by certified check or money order made payable to: "Nevada State Board of Osteopathic Medicine." The certified check or money order must be received by the Board's office no later than 60 days from the effective date of this Order.
- 4. Dr. Jenkins may not apply for reinstatement of his license pursuant to NRS 633.681 and 622A.410(1) for a period of at least one year from the effective date of this Order and not until he satisfies the following terms and conditions:
- (a) Dr. Jenkins has paid the fees and costs ordered in paragraph #2 herein and the fine ordered herein in paragraph #3 in full.
- (b) Dr. Jenkins has attended and successfully completed a program specifically designed to assist physicians with anger, boundary, and impulse control issues. Any such program Dr. Jenkins intends to attend to satisfy the condition of this subparagraph must be approved in advance in writing by the Investigating Board Member and the Executive Director. Dr. Jenkins shall execute whatever documents are required by the program to assure that the program can provide the Board with information regarding Dr. Jenkins' diagnosis, prognosis, treatment, and aftercare arrangements and so that the Board's staff can communicate directly with the program regarding Dr. Jenkins. Before applying for reinstatement, Dr. Jenkins must assure that the program provides directly to the Board's office written evidence of his successful completion of the program and that he has made all required arrangements for and is participating in aftercare as recommended or directed by the program. During the course of his aftercare, Dr. Jenkins shall execute whatever documents necessary to assure that the aftercare provider or program can provide the Board with information regarding Dr. Jenkins' aftercare and so that the Board's staff can communicate directly with the aftercare provider or program regarding Dr. Jenkins' aftercare treatment and progress.
- (c) Dr. Jenkins has established a stable treatment relationship with physicians and other health professionals as appropriate for the treatment of Dr. Jenkins' depression, impulse control disorder, and other mental or physical conditions as they may arise. Dr. Jenkins shall satisfy the Board that he is no longer treating himself for any such mental or physical condition and that he is not being treated non-professionally by colleagues. Dr. Jenkins shall execute whatever documents necessary to assure that any

such physician or health professionals can provide the Board with information regarding Dr. Jenkins' diagnosis, prognosis, and treatment and so that the Board's staff can communicate directly with the physician or health professional regarding Dr. Jenkins' treatment and progress.

- (d) Dr. Jenkins has not violated any provision of law related to the practice of osteopathic medicine, whether state or federal and whether statutory or regulatory, after the effective date of this Order.
- 5. Should Dr. Jenkins fail to timely pay any sums due in accordance with this Order, the Board's staff may take whatever action it deems necessary to effectuate collection of the sums due. If the Board's staff is required to pursue legal action to collect the sums due, it shall be entitled to receive its attorney's fees and costs incurred in the pursuit of the legal action.
